Show starts no earlier than 12:00 p.m.

Cards due by 12:00 p.m.
Show starts no earlier than 1:00 p.m.

### **General Rules 2023**

Reminder: This is a 4-H Educational Event. Livestock shows have proven to be an educational event for 4-H participants in developing life skills. The benefits of livestock shows include social relations, character, family exposure to competition, exposure to cultures, and finance for educations.

- 1. Stevens County will not be responsible for any damages to, or losses of, property for the duration of the show.
- 2. The show management reserves the right to alter &/or combine classes as seen fit. All show day announcements take precedence over previous announcements.
- 3. All exhibitors will keep their areas clean at all times.
- 4. Only 4-H and FFA members, regardless of the state they live in, are able to enter. Exhibitors must own animals shown including showmanship. (Exception: If exhibitor has two or more animals in same class.) Only animals entered in show are eligible for showmanship classes.
- 5. Lambs will show slick shown and free of active club lamb fungus lesions.
- 6. State of Kansas Animal Health Department requirements for county show will be followed. No intact male animals may be shown.
- 7. Livestock shown in breeding classes cannot be shown in market classes.
- 8. Wethers and does may be shown in the meat goat show and will be shown clipped to 3/8" or less. Breeding does not need to be clipped.
- 9. All classes will be split by breed and/or by weight.
- 10. All goats and sheep must have an official USDA premise ID tag to be eligible for the show.
- 11. All cattle will be shown "blow and go." Use of paint, glue/adhesives, and boning soaps will not be allowed. No hair coloring will be allowed in grooming of any beef exhibit. Attempts to alter animal color or breed character including the addition of hair or other added material, natural or man-made is prohibited in beef exhibits. Will be subject to inspection and handling by the cattle superintendents and/or their agents at any time.
- 12. Barns will be open for any members who wish to bring their animals the night before.
- 13. Heifers must have registration papers, otherwise they will be shown as commercial.
- 14. The show management reserves the right for weigh back (10 lbs. hogs, 5 lbs. sheep/goats, 10% beef).
  - Suggestion has been made for a maximum weight limit on lamb and goats.
- 15. The Gas Capital Livestock Show is sponsored by the Gas Capital Livestock Committee and other various sponsors.
